PARTICULARS OF CLAIM

1. The Plaintiff is a company carrying on business as a provider of swimming lessons, mainly to children.
2. Between August 2021 and September 2021 the Plaintiff provided swimming lessons to the Defendant's children Tray Thompson and Tiray Thompson.
3. The agreement for the provision of services between the Plaintiff and the Defendant included the following terms:
 - a. Lessons would be charged at CI\$25 each for group lessons and CI\$30 each for semi-private lessons;
 - b. Fees would be invoiced on a monthly basis and would be payable within 30 days of invoice; and
 - c. Any Fees outstanding more than 30 days from invoice would be subject to a late fee of CI\$25.00 per month.
4. The Plaintiff provided monthly statements to the Defendant but the Defendant has failed to make any payment.
5. As at today's date, the Defendant is indebted to the Plaintiff in the sum of CI\$325.00, together with accrued late fees of CI\$900.00, amounting to a total outstanding balance of CI\$1,225.00.
6. The Plaintiff has requested payment of this sum but the Defendant has failed to pay.

AND the Plaintiff claims:

1. The sum of CI\$1,225.00
2. Fixed costs of CI\$175.00 or such other amount in respect of costs as the Court may assess.
