Result / Order: IT IS HEREBY ORDERED THAT:

1. The applicant shall file and serve an application for tendering the fresh evidence to be relied upon supported by evidence showing compliance with the requirements of section 45 of Eastern Caribbean Supreme Court Act Cap 143 (including the statement referred to but not attached to the application for leave to appeal out of time) within 21 days of the date of this order.

2. The application for leave to appeal out of time and the intended application to rely on fresh evidence, if filed and served, are adjourned for consideration to the next Chamber Hearing scheduled for 27th June 2023.
3. If the application to rely on fresh evidence is not filed and served in accordance with this order it will not be considered by the Court.

Issues: Application for an interim stay

Result / Order: IT IS HEREBY ORDERED THAT:

- 1. The applicant is granted a limited stay of execution of the judgment of Thompson Jr. J dated 10th February 2023.**
- 2. The said US\$120,000.00 plus interest shall be kept in court pending the determination of the appeal or further order of this Court.**
- 3. Costs of the application shall be costs in the appeal.**

Reason: The Court was satisfied that the respondents are entitled to the fruits of victory in the lower court; the applicant will

not suffer irreparable harm if the stay is not granted because there is no cogent evidence that the potential harm to the reputation of the respondents or any of them will be further damaged if a stay is not granted and the damage to the reputation of the financial services sector of Nevis is not a proper basis for granting a stay; and the balance of convenience does not favour the granting of a stay. However, the applicant has reasonable prospects of success on appeal and, if successful, the appeal may be rendered nugatory if the US\$120,000.00 plus interest now paid into court is delivered to the respondents.

Application for leave to appeal against conviction and sentence – Application for an extension of time for leave to appeal

Result / Order:

IT IS HEREBY ORDERED THAT:

The application for an extension of time within which to appeal against conviction and sentence is dismissed.

Reason:

The Court noted that the only ground advanced by the applicant for an extension of time was that the application was out of time and was therefore of the view that in the circumstances, the applicant failed to satisfy the Court that he met the threshold for the grant of an extension of time.
