The application of the Applicant, Samuel Benjamin Bankman-Fried, for security for costs in the sum of US\$200,000.00 is dismissed with costs of \$3,500.00 to the appellants to be paid within 21 days.

Reason: The Court noted that the requirements for the grant of security for costs have not been satisfied for the following reasons:

1. The Appellants are officers of the court and have stated in their evidence opposing the application that they would be in a position to satisfy SBF's reasonable costs of the appeal if ordered to do so;
2. There are three outstanding costs orders against SBF in this appeal and two costs orders against the Appellants in favour of SBF in related proceedings. On a summary review of the various costs orders and the proceedings leading to the orders the net position appears to favour the Appellants;
3. SBF has not complied with paragraph 10 of the order of Williams J made on 18th November 2022 ordering him to give disclosure on affidavit of his equity and debt interest in Emergent;
4. The claim for costs of \$200,000.00 is not supported by any details such as hourly rates of the fee earners, estimated time to be spent and details of the work to be done, making it difficult to estimate what would be a reasonable amount to order for security.

IT IS HEREBY ORDERED THAT:

1. The appellants shall give security for the respondents/applicants' costs of the appeal herein by paying the sum of USD\$165,000.00 into court on or before 12th May 2023.
2. The appellants shall provide evidence of the payment of the sum described at paragraph 1, by

filing evidence of the same, on affidavit, on or before 12th May 2023.

3.
